

Consent to Processing of Personal Data of a Participant and/or Legal Representative

1. Separate Consent

1.1. This consent is a separate statement of consent by the data subject or Legal Representative. It does not replace acceptance of Terms of Service, review of the Privacy Policy, consent to publication of results or other platform actions.

Controller / Platform Operator: Individual Entrepreneur Mikhail Iniashev, Armenia, Yerevan, Kievyan st., 1A, email support@yafers.org, website <https://yafers.org>.

Data subject: an adult competition participant, a Legal Representative of a minor participant, and/or a minor participant whose data is provided by the Legal Representative.

2. Personal Data Covered

2.1. The following personal data may be processed: name, email address and phone number of the User or Legal Representative, date of birth or age category, school, teacher, city, region or country, dance level, selected competitions, disciplines, rounds and categories, registration details and status, payment metadata for the Unlock Admin Fee payable to WIDA and Competition Fees payable to Organisers, invoices, receipts or payment confirmations, history of participation through the Platform, results, placings, marks and related competition records, account technical data, user actions and consent records.

3. Purposes

3.1. The personal data may be processed for creating and maintaining an account, registering the participant for Irish dance competitions, forming categories, transferring data to the Organiser, transferring data to WIDA for WIDA-related administration, competition recognition, association records, rules, results, qualification, verification, audit, reporting, complaints, safeguarding, disciplinary matters or other WIDA functions, preparing competition materials, processing and displaying results, issuing invoices and payment confirmations, recording payment status, support, refunds, disputes, security and audit.

4. Actions With Data

4.1. The Controller may collect, record, organise, store, update, retrieve, use, disclose, transmit, provide access to, restrict, erase, destroy and otherwise process personal data by automated and non-automated means.

5. Transfer to Organiser and WIDA

5.1. The data subject or Legal Representative consents to transfer of participant data to the Organiser of the selected competition to the extent necessary for organising and running that competition.

5.2. The data subject or Legal Representative expressly consents to transfer of participant data to WIDA and processing by WIDA for the purposes listed in this consent and the Privacy Policy.

5.3. This transfer may involve access from countries outside the Netherlands and outside the European Economic Area. Where required, the Platform Operator will rely on an appropriate transfer mechanism or explicit consent for the relevant transfer.

6. Minors, Duration and Withdrawal

6.1. If the participant is under 18, this consent must be given by a Legal Representative. The person giving consent confirms that they have authority to act for the minor and will provide confirmation if reasonably requested.

6.2. This consent remains valid until the purposes are achieved, the relevant retention periods expire, or consent is withdrawn.
